

3. **TERM:** The term of the membership shall be for the Membership Term set forth above, after which time the membership will expire unless renewed before the date of expiration.
4. **ACKNOWLEDGMENT OF RISK AND RELEASE OF LIABILITY:** The Member understands that there is an inherent risk associated with the use of the Golf Club facilities, equipment and programs that may result in an injury to the Member. Therefore, the Member assumes full responsibility for any injury or damages to the Member or Member's guests in, on or about the Golf Club premises and does hereby and forever release and discharge the Golf Club, its owners, employees, and agents from any and all claims, demands, damages, rights or causes of action, present and future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the Member and the Member's guests use, or intended use, of the facilities, equipment and programs.
5. **CLUB ETIQUETTE:** Proper clothing is required. Consideration and courtesy of fellow members and employees is expected. Foul language and abusive behavior will not be tolerated. Follow golf course rules and signage. No single riders when applicable.
6. **LOST AND FOUND:** The Golf Club is not responsible for any lost or stolen items, and Member agrees that any personal property or valuables left at the Golf Club is at his or her own risk. The Golf Club Management advises all members not to bring expensive items or large sums of money to the Golf Club.
7. **CHANGE OF CONTACT INFORMATION:** All members must notify the Golf Club in writing of any phone, mailing or email address changes.
8. **DAMAGES:** Any damage to the Golf Club property by a Member, Member's children or guests shall be the responsibility of the adult member.
9. **GOLF CLUB'S RIGHT TO REVOKE MEMBERSHIP:** The Golf Club Management may revoke membership in the event the Member violates the provisions of this Membership Agreement, or for undesirable behavior, as determined by the Golf Club Management. If the Golf Club Management revokes a membership, the Member must submit any and all Golf Club identification and their signed agreement to the Golf Club. No refund of membership dues will be made in the event of such revocation or under any other circumstances.
10. **MONTHLY PAYMENTS MUST BE PAID EVERY MONTH FOR THE DURATION OF THE PACKAGED MEMBERSHIP:** Signing this form will hold the signee liable for the full amount of package. If the applicant was to terminate the agreement, for any reason, during the year of contract, they are responsible for the full amount disclosed above (Dues\$).
